




World Trade in Goods, 2006 (\$ billions) Trade in merchandise goods between selected countries and regions of the world.

# The Changing Composition of Developing-Country Exports





# What Do We Trade: The Composition of World Trade, 2015









### THE WORLD ECONOMY AT A GLANCE Merchandise Export & Import Volume of the European Union 2010Q1-2015Q1



### THE WORLD ECONOMY AT A GLANCE Merchandise Export Volume by Region 2010Q1-2015Q1




### THE WORLD ECONOMY AT A GLANCE Merchandise Import Volume by Region 2010Q1-2015Q1


### THE WORLD ECONOMY AT A GLANCE Share of Intra-PTA Trade in World Merchandise Exports 1990-2008 (percentage)






### THE WORLD ECONOMY AT A GLANCE World Merchandise Exports by Product Group, bl. US \$ 2013











### Growth in the Value of Commercial Services Exports by Region 2011-2014 (annual percentage change)





Prices of Primary Commodities Jan. 2012-May 2015: Is Intranational Trade responsible?






